# Sandburg Village Pool Rules 2021

## MEMBERSHIP

- All pool members and their guests must observe pool rules and adhere to lifeguard and management requests in the interest of safety and conduct
  - All pool members and guests will respond quickly and politely to staff requests to adhere to pool rules for safety and pandemic considerations
  - Members and guests who have been vaccinated are not required to wear masks while at the pool
- Failure to follow rules will be given a written warning, after 2 warnings your membership will be revoked but if anyone deemed unruly by the pool staff, under the influence of alcohol or exhibiting erratic behavior will be required to leave the pool premises immediately, will be given a written warning and/or may suffer immediate loss of membership without privilege of refund.
- Everyone entering the pool premises is required to stop at the check-in desk and present a valid pool membership card each time.
  - A registered pool member must accompany all guests. Pool members are limited to 4 guests per adult member. Rule violations by a member's guest(s) may result in pool membership revocation.
  - Members who alter their membership cards, or allow transfer to another party, shall forfeit their membership privileges for the remainder of the season without a refund.
  - A membership card will not be granted until the member's photo is taken and is in the computer system. (Photos can be taken at the North and South pools and at FFC Old Town.)

## POOL ACTIVITY

- All access to South Pool must be through main entrance.
  - No smoking allowed on pool premises and within 15 feet of the pool exits.
  - Rubber pants or swim diapers must be worn by children who are not toilet trained.
  - All persons entering the pool are required to take a shower. Footbath must be used prior to entering the roped off area.
  - Children under the age of 14 must be accompanied and supervised by an adult member (18 or older) at all times. Children who are not properly supervised will be asked to leave.
  - If supervising adults leave the pool premises at any time, children in their charge must also leave with them.
  - Children using flotation devices for safety purposes will only be allowed in the pool area under strict supervision of an adult in the water
  - Parents will be held responsible for their children's behavior and violation of any rules. Violators of the pool rules may be required to leave the pool premises at anytime.
  - No eating or drinking allowed within the roped off areas. Glass containers are not allowed on the pool deck.
  - No pets are allowed on the pool premises.
  - Radios, tape players, CD players or other sound producing devices are prohibited except when used with personal headsets.
  - Personal use of the office telephone for incoming or outgoing calls is strictly prohibited.
  - Any accident or emergency must be reported to the pool staff immediately.
  - No running, roller-blading, or riding of scooters, bicycles or tricycles or ball playing allowed in the pool or surrounding areas.
  - Swim lanes are reserved for lap swimming only. Swimmers intending to swim laps during designated swim times shall indicate that intention on daily sign-in log and limit time to 30 minutes when more than two persons are waiting.
  - Lounges and chairs are available on a first come, first served basis; saving them is strictly prohibited.
  - Pool members and guests shall not move umbrellas, tables, or bases. This is the obligation of the pool staff.
  - No diving or cannonballing allowed in the pool.
  - Children may be required to take a simple swim test before entering the deep end of the pool without an adult at the lifeguards discretion.
  - No formal instruction of any sort may be conducted without prior approval of management.
  - Selling, trading or vending of any personal property and or products is strictly prohibited on the pool premises and cabanas.
- Sandburg Village Condominium Homeowners' Association and Fitness Formula are not responsible for personal items left in common areas. **Anyone in violation of the above rules, will be given a written warning, after 2 warnings your membership will be revoked but if anyone deemed unruly by the pool staff, under the influence of alcohol or exhibiting erratic behavior will be required to leave the pool premises immediately, will be given a written warning and/or may suffer immediate loss of membership without privilege of refund.** My signature below states that I have read and agree to abide by the 2021 Pool rules.

## SOCIAL RESPONSIBILITY

Sandburg Village Condominium Homeowners' Association and Fitness Formula Clubs are committed to providing our members, guests and employees with an environment that is as clean and safe as reasonably possible. The cooperation of our members is required to best achieve this goal. To that end, in consideration for access to the Carl Sandburg Village Pools and its equipment, programs, supplies, staff, services, locker rooms and other facilities (collectively the "Facilities"), we ask that you, for yourself and all other members named on your Membership Agreement (together "Member"), acknowledge and agree with Sandburg Village Condominium Homeowners' Association, The Fitness Formula, Ltd. ("FFL") and the FFC Club owners listed below along with any other FFC locations that may be added at a later date (together with FFL referred to herein as "FFC") as follows:

A. Member understands that other members, guests and staff will have access to the Facilities. While FFC takes reasonable steps to insure the safety and sanitization of the equipment, programs, supplies, services and Facilities, Member acknowledges that FFC cannot and does not guarantee that the Facilities are germ/virus free (this includes but is not limited to COVID-19).

B. Member agrees:

- (1) If required, to have his or her temperature taken by a FFC employee upon entering a FFC Club and if his or her temperature is equal to or greater than 100.4 degrees, he or she will not be admitted to the FFC Club on that day;
  - (2) to not seek entry to or use of the FFC Club if Member feels sick or exhibit any of the signs or symptoms of COVID-19;
  - (3) that Member may be denied access to and use of the FFC Club unless Member truthfully confirms that he or she is well, does not have signs and symptoms of COVID-19, and has not knowingly been exposed in recent days to a person diagnosed with COVID-19; (4) to adhere to any health, safety, social distancing and protective guidelines established by Sandburg Village Condominium Homeowners' Association, FFC or the U.S Centers for Disease Control, World Health Organization, State of Illinois or other federal, state or local governmental agency, or recommended by the International Health Racquet Sports Club Association.
- C. Member understands, acknowledges and agrees that access to and use of the Facilities by Member is voluntary and that they involve inherent risks. As material consideration for access to and use of the Facilities, Member agrees to specifically assume all risks of personal injury, illness and death, property loss and other damages including, without limitation, risks of contracting COVID-19 or other bacterial or viral illnesses, associated with fitness classes and equipment, sports exercise, all locker room facilities and fitness advisory services and all other Facilities, and Member hereby releases, waives, discharges and covenants not to sue Sandburg Village Condominium Homeowners' Association, First Service Residential, FFC, The Fitness Formula, Ltd. and their respective officers, directors, managers, owners, partners, employees and agents ("FFC Parties") for any and all claims, liabilities, losses, costs, damages and expenses that Member may have against any FFC Parties for any personal injury, illness or death, property loss or other damages connected to or arising out of the associated risks. Any dispute between Member and any of the FFC Parties under this Agreement will be resolved by arbitration in Chicago, Illinois in accordance with the rules of the American Arbitration Association. This Social Responsibility Agreement constitutes an amendment to, and does not replace, the Membership Agreement between FFC and the Member. Member has the full power and authority to bind himself or herself and all other members named in such Membership Agreement to this Agreement. Signatures to this Agreement transmitted by electronic means (including facsimile transmission or electronic mail transmission of a portable document format document) or affixed as an electronic signature shall be deemed and treated as original signatures and shall be valid and effective to bind Member to this Agreement.
